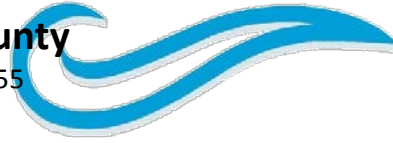

STANDARD FEE SCHEDULE

PLAN REVIEW FEES

Water Only	\$ 100
Water & Sewer	\$ 250
Subdivision (w/ 5 or more lots)	\$ 25
Site Plans	\$ 50

CONSTRUCTION INSPECTION FEES

Water Lines	\$ 1	per ft of installed pipe
Sewer Lines	\$ 1	per ft of installed pipe
Reinspections ¹	\$ 50	

¹Amount to be paid prior to reinspection

CAPACITY FEES (One Unit of Flow = One equivalent single family residential unit = 350 gallons per day usage)

Water	\$ 500	per unit of flow
Sewer	\$ 750	per unit of flow
Capacity Study	\$ 250	

WATER TAP FEES (¾" Service) - NEW RESIDENTIAL DEVELOPMENT

< 10 Lots	\$ 1,000 ea.	
11 to 29 Lots	\$ 750 ea.	(25% Discount)
> 29 Lots	\$ 500 ea.	(50% Discount)

SEWER TAP FEES - NEW RESIDENTIAL DEVELOPMENT

< 10 Lots	\$ 1,000 ea.	
11 to 29 Lots	\$ 750 ea.	(25% Discount)
> 29 Lots	\$ 500 ea.	(50% Discount)

WATER TAP FEES - TAPS ON EXISTING WATER MAINS - INDIVIDUAL WATER SERVICE CONNECTIONS

¾" Service Tap	\$ 1,000
1" Service Tap	\$ 1,250
1-½" Service Tap	\$ 2,000
2" Service Tap	\$ 2,500

SEWER TAP FEES - TAPS ON EXISTING GRAVITY AND PRESSURE SEWER MAINS - INDIVIDUAL SEWER SERVICE CONNECTIONS

Residential	\$ 1,000	plus cost of material
Commercial	\$ 1,250	plus cost of material

CONNECTIONS TO EXISTING WATER AND PRESSURE SEWER MAINS

3" X 3" Mainline Tap	\$ 1,000	
4" X 4" Mainline Tap	\$ 1,000	
6" X 6" Mainline Tap	\$ 1,000	
8" X 8" Mainline Tap (and Larger)	\$ 1,000	plus additional material cost

MISCELLANEOUS FEES

Service Connection Fee (Residential)	\$ 60	(Assessed per Account - Water or Sewer, not both)
Service Connection Fee (Commercial)	\$ 100	(Assessed per Account - Water or Sewer, not both)

MISCELLANEOUS SEWER FEES

Sewer Service Deposit (Residential)	\$ 40
Grinder Pump	\$ 3,100

MISCELLANEOUS WATER FEES

Water Service Deposit (Residential)	\$ 40
Fire Hydrant Meter Deposit	\$ 400
Fire Hydrant	\$ 3,500
Second Meter (Residential Only)	\$ 1,000
Backflow Device Inspections	\$ 45
Tampering/Destruction Fee	\$ 100
Disconnect Fee for Nonpayment (business hours)	\$ 35 plus past due amt
Leak Adjustments ²	\$ 3 per 1,000 gallons for amount above average usage
