WATER AUTHORITY OF DICKSON COUNTY APPOINTS NEW EXECUTIVE LEADERSHIP TEAM

Dickson County, TN – January 14, 2025 – The Water Authority of Dickson County (WADC) is pleased to announce the appointment of a new executive leadership team following the retirement of Interim Executive Director Danny Bledsoe in December 2024. After several months of thorough interviews, meetings, and work sessions, the WADC Board of Commissioners has unanimously appointed Scott Miller as Chief Executive Officer (CEO), Susan Tummins as Chief Financial Officer (CFO), and Michael Rogers as Chief Strategy Officer (CSO).

The appointments were officially made during the board meeting held on January 13, 2025, where a motion was passed to solidify the new leadership structure. This decision marks a significant step forward for WADC as it aims to enhance operational efficiency and continue providing high-quality water and wastewater services to the community.

"Scott, Susan, and Michael bring a wealth of experience and knowledge to their new roles, and we are confident in their ability to lead the Water Authority into the future," said Todd Murphy, Chairman of the WADC Board of Commissioners. "Their diverse backgrounds and strategic vision align perfectly with our goals to enhance services and better provide for the residents of the communities we serve."

Susan Tummins, M.B.A., has over 25 years tenure with the authority in the financial department. As CFO, Tummins will oversee the financial health of the organization, ensuring financial stability and compliance with regulatory standards. Michael Rogers, P.E., has been the Engineering Manager for WADC since 2015. Serving as CSO, Rogers will focus on developing and implementing innovative strategies to enhance WADC moving forward.

The Water Authority of Dickson County remains dedicated to its mission of providing reliable and safe water and wastewater services while navigating the challenges of growth and sustainability in the community. The board looks forward to the contributions of the new executive leadership team as they embark on this important journey.
